

It is agreed, the undersigned (hereafter known as VENDOR) will rent booth space at the Darlington Downtown Revitalization Association (DDRA) **Bringing Downtown Alive! Concert Series** at Liberty Lane, 116 Pearl St.

VENDOR will utilize a designated space in the Downtown area of Darlington, SC, for the purpose of selling food to attendees of DDRA free concerts. UNLESS OTHERWISE AGREED IN WRITING, NO BEVERAGES MAY BE SOLD, ONLY FOOD.

The standard space shall be 10 feet wide and 6 feet deep. However, additional space may be utilized subject to the approval of the DDRA Director.

The DDRA Concert Committee limits the number of vendors and controls the specific categories. However, the VENDOR acknowledges the competitive spirit and accepts any and all other vendors as fair and equal competition. The DDRA Concert Committee reserves the right to locate or relocate vendor space as needed. **VENDOR agrees to locate at the area designated by the DDRA Concert Committee, without exception.**

VENDOR agrees to participate for the full duration of the DDRA event, which shall be from 7 p.m. until 10 p.m. It is understood that setup shall not begin before 1:00 p.m. the day of the event and all setup must be completed by 6:00 p.m. **Teardown may begin once the band has finished their final set and all vendors must be out of the area by 11:00 p.m.**

VENDOR will forfeit booth space not occupied by 5:30 p.m. In the event of forfeiture, no refund of money will be made and the DDRA Director reserves the right to substitute another vendor for that event and the balance of the concert series.

DDRA will provide one six-foot table if requested. The VENDOR must provide other supplies they may need, unless otherwise agreed by the DDRA Director.

Electricity will be provided where available. Standard 120 volt / 20 amp electrical power will be provided where available. Vendors needing 220 volt or high amperage 120 volt power will need to coordinate their needs with the DDRA Director. Vendor is responsible for providing all needed extension cords.

In the event of inclement weather, the DDRA Concert Committee reserves the right to cancel the event. In the event of a total cancellation, a refund will be made to all VENDORS. If the event begins and is then called for inclement weather, no refunds will be given.

VENDORS must have or must obtain a City of Darlington Business License. Proof of same will be requested prior to setup. All VENDORS, if applicable, must meet South Carolina DHEC regulations. In the event that DHEC regulations are not met, no refund will be given.

The VENDOR will indemnify and hold harmless the Darlington Downtown Revitalization Association, The DDRA Concert Committee, The City of Darlington, participating sponsors and their representatives, employees and agents against any and all liability whatsoever arising from any damage to property or personal injury or loss caused by VENDOR, it's agents, representatives, employees or such other persons.

All matters and questions not covered by this agreement are subject to the decision of the DDRA Director and/or DDRA Concert Committee. The DDRA Director shall have the authority to promulgate, interpret and enforce all rules and regulations and to make any amendments necessary for the orderly conduct of the DDRA events.
